

# CONTRACT

## to provide paid educational services on specialist training at Osh International Medical University

Osh International Medical University represented by the Rector, **Dzhumaev R.M.** hereinafter referred to as "OIMU", acting on the basis of the law of KR "On Education", legislative acts of the Kyrgyz Republic in the field of education, the University Charter on the one hand and

On the other hand, hereinafter referred to as the "Student", have entered into this agreement as follows:

### I. I. Subject of the contract

The University undertakes to train specialist on the contract basis by specialty on **General Medicine** leads to

1.1. The student pays the tuition fee to the university in the prescribed amount and manner.

## 2. Duties and Rights of the parties

### 2.1. OIMU is committed to:

2.1.1. According to the results of ORT and / or entrance examinations in the presence of all relevant documents to enroll in 1<sup>st</sup> year of OIMU with the issuance of a student card (in hard or electronic form) and provide a credit book (in hard or electronic form).

2.1.2. Create necessary condition for a complete education and all-round development of personality in accordance with the qualification characteristics of the specialist in the chosen specialty.

2.1.3. Organize and conduct educational work with students during the entire period of study. To monitor the attendance and progress of students, including the use of distance learning technologies.

2.1.4. Provide social guarantees and protect the legal interests of the "Student" in the prescribed manner.

2.1.5. Upon completion of course tenure, issue the "Student" a diploma of education of the established pattern of the Kyrgyz Republic in the state, Russian and English (for foreign students) languages.

### 2.2. The OIMU has the right to:

2.2.1. Adjust tuition at the beginning of each academic year to account for inflation and the real costs of the university.

2.2.2. To issue orders: about the enrollment of the applicant in OIMU, about the transfer of the "Student" from course to course, from one specialty to another, about the expulsion and reinstatement.

2.2.3. To dissolve the contract on specialist training at OIMU in case of nonpayment of 50% of the fee for the 1st course before 20<sup>th</sup> of September by full-time students from the Kyrgyz Republic, not to admit the "Student" to the classes and accordingly to issue an additional order on his/her expulsion. For foreign students in case of non-payment of 50% of the fee for the 1st course within 10 days after enrollment in the University.

2.2.4. To expel the "Student": for failure to pay tuition fees in a timely manner; for academic failure; for unexcused absences more than 60 academic hours or 48 hours in the credit system per semester, for violation of university internal regulations, as well as at his/her own request.

2.2.5. When a student is expelled under paragraph 2.2.4. of this contract, the academic transcript is issued after the tuition fee has been paid for the period prior to the date of the order of expulsion, and if prepayment has been made, the refund of the tuition fee paid by the student is made after deduction of the money spent for the period of study prior to the date of expulsion.

2.2.6. Provide, at the request of the "Student", various educational services for an additional fee and provide, if necessary and as far as possible, a place in the dormitory.

2.2.7. Revise tuition to reflect the new rates when the student returns from sabbatical leave or is reinstated.

Organize at the initiative of students extra summer semesters to eliminate academic debts for an additional fee, the cost of which is determined by calculation, depending on the number of credits and study load.

### 2.3. The student commits to:

- 2.3.1. Observe charter, regulations learning, rules internal routine, fulfill orders and orders guides university.
- 2.3.2. Observe the Charter, the rules of training, the rules of internal order, follow the orders and instructions of the university management.
- 2.3.3. Attend the established forms and types of classes provided by the relevant curriculum and programs of study and comply with the schedule of the educational process.
- 2.3.4. Pay 50% of the first-year tuition by 20<sup>th</sup> September and the remaining 50% by 1<sup>st</sup> February of the academic year. For international students, pay 50% of the first course fee within 10 days of enrolling at the University, the remaining 50% must be paid by 1<sup>st</sup> February of the academic year.
- 2.3.5. On subsequent courses to pay tuition with the payment of 50% of the contract amount by 1<sup>st</sup> October, for the second half of the year (50%) - by 1<sup>st</sup> February. Pay the tuition according to the rates posted on the website [www.oimu.kg](http://www.oimu.kg) after transfer to subsequent courses.
- 2.3.6. If a student interrupts his or her studies for any reason, he or she must write a statement about it to the Rector from the date of suspension of attendance. If the student from the beginning of the educational process until the expulsion from the educational institution has not made payment for contractual training, then until the repayment of debt for the actual period of study (according to the order) his/her personal documents and academic certificate will not be issued and will be in temporary storage in the administration of OIMU.
- 2.3.7. Actively participate in social and cultural activities, treat with care the property of the university, and reimburse the damage caused in cases of damage to the property by the student. After the conclusion of this contract to submit educational documents in the original with a translation into the state (or Russian) language.
- 2.3.8. Be personally responsible for the accuracy and validity of all documents submitted by him.

### 2.4. The student has the right to:

- 2.4.1. To acquire knowledge corresponding to the modern development of science, technology, and culture at the level of the requirements of state educational standards.
- 2.4.2. Receive information about their orders for enrollment, transfer, reinstatement, and expulsion from the university.
- 2.4.3. To take part in the discussion and resolution of the most important issues, in various forms of technical creativity and artistic amateurism, not contrary to the laws of the Kyrgyz Republic.
- 2.4.4. To be a member of the University's student organization and to protect through it their social and legal rights, as well as to elect and be elected in the prescribed manner to the authorities and student government of the University.
- 2.4.5. For the creation of cultural and educational national centers and student public associations, the dissemination of reliable information about the university.
- 2.4.6. Request a one-year academic leave of absence for health reasons and in accordance with the regulations.

### 3. Other conditions

- 3.1. This contract enters into force from the date of its signing by the parties and is valid for the entire term of the student's education.
- 3.2. If either party fails to fulfill its contractual obligations, this contract may be terminated prematurely by either party after 10 days written notice or by e-mail.
- 3.3. Disputes arising between the parties hereto shall be resolved in the manner prescribed by the laws of the Kyrgyz Republic.
- 3.4. The contract is made in two copies, one for each party.
